AN ORDINANCE OF THE BOARD OF TRUSTEES OF THE TOWN OF
SUPERIOR AMENDING SECTION 8-1-60 OF THE SUPERIOR
MUNICIPAL CODE CONCERNING PARKING ON PUBLIC STREETS

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF
THE TOWN OF SUPERIOR, COLORADO, THAT:

Section 1. Section 8-1-60 of the Superior Municipal
Code, subsections (b) (3) and (4), are hereby amended to read as
follows:

Sec. 8-1-60. Parking violations.

* * *

(b) Specific violations.

* * *

(3) Trailers. *It is unlawful to park any semi-trailer on any public street, alley or right-of-way adjacent to any residential lot, regardless of whether such semi-trailer is properly licensed or registered.* It is unlawful to continuously park any *other* trailer, ~~semi-trailer or utility trailer~~ for more than ~~five (5) days~~ *forty-eight (48) hours* on any public street, alley or right-of-way, regardless of whether such trailer, ~~semi-trailer or utility trailer~~ is properly licensed or registered. A trailer, ~~semi-trailer or utility trailer~~ that is moved from a parking space on any street block and re-parked on the same street block within any twenty-four-hour period shall be deemed to have been continuously parked. ~~This~~ *These* prohibitions shall not apply if the trailer *or* semi-trailer ~~or utility trailer~~ is parked on a public street, alley or right-of-way for the purpose of construction activity occurring on the immediately adjacent property, provided that all the required permits and approvals for the construction activity have been issued by the Town and all other necessary authorities.

(4) Recreational vehicles. It is unlawful to continuously park any recreational vehicle for more than ~~five (5) days~~ *forty-eight (48) hours* on any public street, alley or right-of-way. A recreational vehicle that is moved from a parking space on any street block and re-parked on the same street block within any twenty-four (24) hour period shall be deemed to have been continuously parked.

Section 2. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision

shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Board of Trustees hereby declares that it would have passed this Ordinance and each part or parts hereof irrespective of the fact that any one, or part, or parts be declared unconstitutional or invalid.


Section 3. Safety. This Ordinance is deemed necessary for the protection of the health, welfare and safety of the community.
