A RESOLUTION OF THE BOARD OF DIRECTORS OF THE
SUPERIOR/MCCASLIN INTERCHANGE METROPOLITAN DISTRICT
CONDITIONALLY CANCELING THE MAY 8, 2018, REGULAR
DISTRICT ELECTION AND CONDITIONALLY ELECTING BY
ACCLAMATION THE CANDIDATES NOMINATED FOR DIRECTOR

WHEREAS, pursuant to C.R.S. § 1-13.5-513(1), if, at the close of business on March 6, 2018, the 63rd day before the election to be conducted on May 8, 2018, there are not more candidates for director than offices to be filled, including candidates filing affidavits of intent to be write-in candidates, the Board may cancel the election;

WHEREAS, the Board anticipates that will be the case, but is obligated to comply with statutory requirements; and

WHEREAS, the Board has held a meeting regarding its intention to cancel the election.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SUPERIOR/MCCASLIN INTERCHANGE METROPOLITAN DISTRICT AS FOLLOWS:

Section 1. Pursuant to C.R.S. § 1-13.5-513, the Board of Directors hereby cancels the May 8, 2018 regular election of the Superior/McCaslin Interchange Metropolitan District if, at the close of business on March 6, 2018, there are not more candidates for director than offices to be filled, including candidates filing affidavits of intent to be write-in candidates.

Section 2. The Board of Directors hereby declares that the following candidates shall be considered elected to the office of director for the following terms of office, provided that this declaration shall be effective only upon occurrence of the conditions set forth in Section 1 above:
